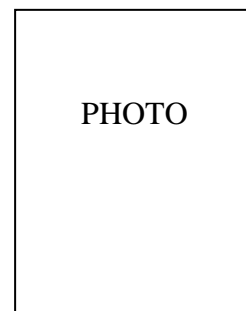


ATTESTATION FORM
