Sant Longowal Institute of Engineering & Technology (SLIET) was established by the Ministry of Human Resource and Development (MHRD), Govt. of India in 1989, with a vision to act as a nodal centre for developing human resource for catering to the needs of industries (skilled workers, supervisors, engineers and managers), universities (teaching and research), R&D establishments, and motivating them to serve the nation by becoming bureaucrats, entrepreneurs, social activists, and politicians.
