#### Guidelines for

## Budgetary Allocation to conduct of STTP/STC/Workshop/Conference etc. under TEQIP-III

- 1. The organizer will be required to apply on a standard proforma provided by the TEQIP-III cell.
- 2. Different activities which can be carried out by various departments under TEQIP-III:
- (a) STTP/STC/SDP/Conference/Industry Institute Interaction/others: Maximum two activities can be carried out per department in a financial year. However, the limit of maximum activities by a department can be relaxed by the Competent Authority.
- (b) Funds allocation for above mentioned activities for each department under TEQIP-III shall be maximum ₹2.00 Lacs in the first phase. However, limit may be extended by the competent authority.
- (c) The bifurcation of expenditure of the funds allocated under TEQIP-III is as under.

- (d) The Honorarium and TA/DA to the experts/invited speakers will be as follows:
  - TA/DA should be given as per institute norms, however under special cases TA/DA as per TEQIP-III guidelines may be given to the expert's subject to approval of Director, SLIET.
  - Honorarium to experts (External): ₹5000 per day (reference no. F.No.16-26/2017-TS.VII dated 27/09/2017).
  - No honorarium will be paid to the experts from SLIET, Longowal and mentee institute (NIT, Uttarakhand).
- (e) Criteria for organizing activity:
  - Minimum of 20 participants should be ensured in STTP/STC/SDP.
  - Minimum of 50% of total lectures scheduled should be delivered by the external experts.
  - TA/DA to participants is not allowed in any of the above activities.
  - Minimum Registration Fee: ₹1000 per participant from other educational/research institutions/organizations; ₹.1500 per participant from industry; ₹500 per research scholar/student.
  - Submission of the proceedings of all of the above activities to the TEQIP cell is mandatory preferably in CD.
  - List of participants along with affiliation, contact details as per format (Annexure-I)
