OFFICE ORDER

In continuation to Office Order No. SLIET/REG/9166 dated 02.07.2020 and in compliance to the OM No. 16-16/2020-U.I A dated 06.07.2020 issued by the Government of India, MHRD, New Delhi and Order No. 40-3/2020-DM-I (A) dated 29.07.2020 issued by Government of India, Ministry of Home Affairs, New Delhi vide which guidelines for phased re-opening (Unlock-3) and National Directives for COVID-19 Management have been circulated, for the students, the Institute is closed upto 31.08.2020. However, online/distance learning shall continue to be permitted and encouraged.


All Administrative and Departmental Offices shall function as usual.

All faculty and staff members are required to attend offices with maintaining social distancing and following SOP prescribed by Government of India, Ministry of Home Affairs, New Delhi.

The faculty/staff coming from outside campus on daily basis should undergo thermal scanning at the Main Gates of the Institute.

The faculty/staff coming from outside campus after availing work from home facility shall be required to visit SLIET Health Centre at the time of joining, where they will be going under medical check-up by the Medical Officer, SLIET and submit a declaration in the enclosed proforma to the Medical officer who will countersigned it and hand over the same to the concerned faculty/staff for submission to the concerned HoD/Section In-charge.

Faculty/staff not able to attend office on a particular day will work from home (place of residence as per Institute record) with due permission of HoD/Section In-charge.


The students staying in the Hostel are advised to take all necessary safety precautions.
