**Eligibility for OBC (Non Creamy Layer) Reservation:** For applying to avail reservation under OBC category, the candidates will be required to submit adequate proof /certificate, issued by the competent authority as may be prescribed from time to time in evidence of his/her not belonging to creamy layer. The criteria of creamy layer will be applied as may be prescribed by the Govt. of India from time to time. At present, notification issued by the Ministry of Human Resource Development, New Delhi, prescribes that the candidates whose family income does not exceed Rs 8 lacs per annum as per OM No. 36033/1/2013-Estt.(Res) dated 13 September, 2017 (the amount will be governed by latest guidelines of Govt. of India) and do not fall within the category of creamy layer.

**The above proof/certificate should pertain to the financial year 2019-20 and certificate issued on or after 01.04.2020 will be considered.**
