

Item 4.1	TO CONSIDER AND APPROVE PAYMENT OF FELLOWSHIP FROM AUGUST, 2020 ONWARDS TO PH. D. RESEARCH SCHOLARS
	<p><b><u>Agenda</u></b></p> <p>Due to Covid-19, the Ph. D. research scholars are not attending the Institute physically since March, 2020. However, with approval of the Senate in its 28th meeting held on 21.05.2020 and 29th meeting held on 17.07.2020, they have been allowed payment of fellowship upto July, 2020, out of GIA / TEQIP funds, based on individual claims submitted by them and duly verified by concerned supervisor (s) and HOD (s).</p> <p>As reported by the academic section, from August, 2020 onwards, these research scholars are not being paid the fellowship, for want of any decision in this regard,</p> <p>The matter is placed before the Standing Committee for deliberations and decision, please.</p>
	<p><b><u>Decision</u></b></p> <p>After discussions, it has been decided that the fellowship to all the Ph. D. Research Scholars shall be paid for the months of August, September and October, 2020, based on the submission of proforma circulated for monthly progress report. Henceforth, the monthly scholarship shall also be submitted along with attendance and monthly progress.</p> <p>However, from November, 2020, onwards, the research scholars, are required to join the Institute by 10th of November, 2020. In case, he/she does not turn up by this date, fellowship shall not be paid to him/her.</p> <p>It is also decided that Dean (R&amp;C) shall incorporate the necessary modifications in the Ph. D. Ordinances, accordingly. Further, amendment be done to assess R/S progress in each semester (i.e. Jan to June and July to December).</p>
