**NOTIFICATION**

In pursuance of Cabinet Secretariat Notification No. CG-DL-E-17082020-221168 dated 17<sup>th</sup> August, 2020 notifying amendments under Schedule I and Scheudle II of the Government of India (Allocation of Business), the erstwhile Ministry of Human Resource Development, henceforth, shall be officially known as 'Ministry of Education (Shiksha Mantralaya)'.

As communicated by Ministry of Education (Shiksha Mantralaya), Government of India, vide Order No.A44011/6/2020-E.I (copy enclosed), therefore, the following changes are necessitated and put in place by all concerned:

- i. All official communications emanating from the Ministry shall bear the new title 'Ministry of Education (Shiksha Mantralaya)' in lieu of MHRD. The two Departments, namely, Department of Higher Education and Department of School Education & Literacy shall continue to retain their existing names and exchange of correspondence shall be as per the same.
- ii. All name plates, signage, stationery, mark sheets, degrees and other material of public display and advertisement, website, etc. to reflect the changed name, viz. Minsistry of Education (Shiksha Mantralaya) substituting MHRD wherever occurring.
- iii. All contracts and agreements entered into till date with Ministry of Human Resource Development (MHRD) shall in the wake of change of name thus effected shall be deemed to be entered into with Ministry of Education (Shiksha Mantralaya) and accordingly shall be the case with all future contracts and agreements.

This shall come into force with immediate effect.


**ORDER**
