- 1. An earnest money deposit (EMD) of Rs. 20,000/- (Rupees Twenty Thousand only) in the form of demand draft drawn in favor of Director SLIET at Longowal must be deposited along with quotation form, failing which quotation shall be rejected.
- 2. The tenderer may inspect the standing crop to be auctioned on any working day starting from 29.06.2021 to 05.07.2021 (from 9:00 AM to 5:00 PM) with the permission of Estate Officer.
- 3. The agency has to quote highest bid in sealed envelope for acceptance.
- 4. For any clarification regarding the auction, the bidder may contact to Registrar, SLIET Longowal.
- 5. No cash transaction for payment will be entertained.
- 6. The tenderer/bidder should mark his signature in the tender form, without which the bid is liable to be rejected.
- 7. The sealed quotation along with EMD should reach this office by speed post/by hand before the last date and time of submission of the tender.
- 8. The SLIET Longowal will not be responsible for any postal delay.
- 9. Quotation received after last date and time will not be entertained.
- 10. The sealed envelope should be clearly super scribed as "QUOTATION FOR AUCTION OF JAMUN/BLUEBERRY AT SANT LONGOWAL INSTITUTE OF ENGINEERING AND TECHNOLOGY LONGOWAL, DISTRICT-SANGRUR, PUNJAB-148106.
- 11. Bidder/tenderers are at liberty to be present or authorize in writing a representative to be present at the time of opening of tenders.
- 12. The Director SLIET reserves the right to accept or reject any bids without assigning any reason.
- 13. There should be no damages to the experimental material or fencing of the boundary etc. In case there is any damage, the successful bidder would bear the cost of the damages.
- 14. Any tax if applicable shall have to be paid by the successful bidder
- 15. Produce except those auctioned will not be allowed to be removed. In the case the highest bidder or his worker is found doing so, the contract will be nullified and the money deposited for the purpose will be fortified.
- 16. The Director SLIET or any of the nominated persons will have freedom to visit/inspect the orchard area at anytime.
- 17. The watch and ward for all the produce will be responsibility of the contractor failing which the present contractor will be nullified and will be Blue listed from the future auction.
- 18. Firewood should not be used for cooking etc. in the site area/orchard in any case. If any worker is found doing so the contractor will have to pay the penalty fixed by the Director SLIET.

- 19. The contractor cannot sub-lease the contract further.
- 20. If any fire occurs due to the negligence of the contractor or workers, the contractor has to pay the damages cost fixed by the Director SLIET.
- 21. The contractor will not be allowed to keep the family in the site area/orchard and the worker will stay adjacent to the plot/block for guarding the fruits in a temporary hut only.
- 22. Contractor will not be allowed to remove, damages any property of the SLIET. Contrary to his necessary action as mentioned under the terms & condition will taken.
- 23. After completion of contract, the contractor is required to hand over the site which he has received at the time of auctioning/award of contract to the Director SLIET or any nominated persons by the Director SLIET.
- 24. Sale of the produce in the orchard area will not be allowed in any case.
- 25. The contractor will be required to intimate the name of the person with the full address and photocopy of identity required for entering in SLIET. SLIET will not bear any cost on account of salary & other allowance to the workers to be deployed by the contractor.
- 26. The entire contract will be nullified and the money deposited for the purpose will stand forfeited in the event of the violation of the above terms and conditions and in no circumstances will be allowed to subject the contract further.
- 27. The successful tender would be responsible for manuring, watering, pest control and transportation of harvest/fruit at his own cost.
- 28. The organization will provide only water required for watering of trees/ plants will be provided by SLIET at applicable charges. However, the watering to plants/trees are to be arranged by the successful bidder.
- 29. The successful tenderer/ bidder would ensure maintenance of the site area/orchard/ at highest standard and will cooperate in all respect toward the same.
- 30. It shall be the responsibility of the successful tendered/bidder to meet all the requirements as per prescribed under the various laws and statutes, as in force and amended from time to time. Failure to comply with the applicable labour laws, rules and regulations shall entail necessary action as mandated under the respective laws and also Blue listing by the SLIET.
- 31. The successful tender/bidder should execute an agreement on non-judicial stamp paper of Rs. 100/-within one week from the date of acceptance.
- 32. Jamun/Blueberry do not have any kind of fencing. It may be noted that there are around 4,000 residents in this Campus. Any dispute should not occur at the cost of plucking of fruits by the residents/students.
- 33. The contract will be valid of 60 days from the date of award, which may be considered for extension for a further period as decided by the Competent Authority on rates and terms and conditions, mutually agreed upon by both the parties.
- 34. The agency has to nominate the authorized person. The Jamun/Blueberry shall be weighed in the presence of nominee of Director, SLIET. The gate pass shall be issued for outward movement of the Blueberry (Jamun) by the institute. The amount has to be deposited in the Bank account of SLIET before the Blueberry/Jamun is allowed to pass through gate of SLIET for outward movement.
