
NOTIFICATION

CIRCULAR

It is brought to notice of all the Technicians that the BoM in its 35th meeting held on 20.03.2020 vide Resolution No. 35.07 has authorized the institute to conduct Departmental Promotion Committees for promotion to different non teaching posts strictly as per RRs approved by the BoM in its 11th/13th meetings held on 21.09.2012 & 12.07.2013 respectively.

Accordingly, the Institute issued a notification No. SLIET/Admn./8166-67 dated 03.06.2020 notifying 09 vacancies (UR-08, SC-01) of Senior Technician in the Pay level-06 for promotion through DPC. However, the candidates of feeder cadre post i.e., Technicians made representations and raised some points.

The representations received from the Technicians have been considered by the Departmental Promotion Committee and resolved that none of the points raised by the Technicians has any substance.

Therefore, all the candidates of feeder post i.e., Technicians are given one more opportunity to submit their unconditional consents for considering their names for promotion to the post of Senior Technician through DPC as notified vide Notification No. SLIET/Admn./8166-67 dated 03.06.2020 in the enclosed proforma.

It is further clarified that there will be only change of designation without any fixation of pay and change of pay level, i.e., the promotes will be allowed to draw the same pay in the existing pay level in which they are presently working. There will be no department-wise bifurcation of posts. The recommendations of the DPC shall be applicable only from the date of DPC meeting without any retrospective effect.

The consents of the interested candidates in the prescribed proforma shall reach the Registrar's Office within 10 days from the issue of this circular.
