Other term and conditions:

- (i) A complaint from an aggrieved student relating to the Institution shall be addressed to the Chairperson, Student Grievance Redressal Committee (SGRC).
- (ii) The term of the Chairperson and Members shall be for a period of two years and the term of the Special Invitee shall be one year. The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- (iii) The SGRC shall send its report with recommendations, if any, to the competent authority of the Institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
- (iv) Any student aggrieved by the decision of the SGRC may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.
