NOTICE

As per approval by Ministry of Education, GOI, the Research Assistants shall be engaged in each department. The research Assistants shall be engaged on tenure track basis, initially for a period of two years and extendable for another one year (maximum 2 times) on a consolidated wage of Rs. 25000.00 per month. The eligibility condition shall be GATE/NET (AP) qualification, i.e. identical with qualification for institute fellowship. The Research Assistants can be enrolled/register for Ph.D. degree as per rules and regulations of the institute for its Ph.D. programmes. In addition to the research related activities of the Research Assistants, they shall be given a teaching load of 8 hours per week at ICD level. The distribution of Research Assistants during academic session 2023-24 for all departments shall be as under:

The Research Assistants shall be provided to the departments against the proposals received from the department, duly recommended by DRC of the department, indicating the requirement of development of particular lab (s).

This distribution may change, in view of the availability of suitable candidates, subject to maximum of 12 Nos. of Research Assistants in a year. Under Central Facility, the candidate from any of the department can be engaged.

While allocating the scholars at department level, the preference shall be given to the faculty member having no research student with institute fellowship at present.

Detailed Proposals in the following format are required to be submitted in the Office of Dean (R&C) on or before 22.06.2023.

- Project Title
- Project summary (Including brief Literature survey)
- Objectives of project
- Expected output and outcome of the proposal
- · Consumables required, Equipment required, Contingency etc.

The research proposal must include the followings:

- The name of the laboratory and the Thrust area/focused area of research are required to be identified in which the Research Assistant shall work and the outcome thereafter.
- · Availability of equipment/items in the department for execution of the research proposals submitted by the faculty.
- Certification by the department that the facility required for execution of the research proposals is available in the department or in the allied departments.
- Possibility of meeting out the recurring expenditure from the funds allocated to the department (recurring/non-recurring), if any.

The project proposals shall be scrutinized by the committee duly constituted by the Director. Further, the selection committee of the concerned department shall give its recommendations regarding the selection of the candidates under this category.
