CIRCULAR

The AICTE vide letter No. 27/T&I.B/Pay/01/2023-24/27 (Aug) dated 17.08.2023 clarified that the additional qualifications i.e.. under going industrial training, pedagogical training, faculty induction program, publishing research paper etc, as mentioned in para 1.4 (c) of AICTe Gazette Notification dated 1st March, 2019 are included in the mandatory requirement for promotion of faculty under Career Advancement Scheme (CAS) which they can now fulfill till 31st July, 2024 for availing benefit of promotion retrospectively as outlined under para 1.4 (c) of AICTE Notification dated 1st March, 2019.

In view of above clarification received from AICTE, it is for all information of all faculty members that the Clause 1.7 of Guidelines/Rules of promotion for faculty under CAS-2020 may be read with reference to above clarification issued by the AICTE.

Sub.: Clarifications regarding extension of fulfilling of requirements for promotion of faculty under CAS – reg.

Sir,

This is with reference to your letter Ref. No. SLIET/Admn./2023-24/1197-98 dated 29.05.2023 on the subject noted above.

In this connection, you are informed that under para 1.4(c) of AICTE Gazette Notification dated 1st March 2019 it is enjoined upon those who are eligible for promotions after the date of publication of this Gazette, shall to meet the necessary conditions such as additional qualification, undergoing industrial training, pedagogical training, faculty induction program, publishing research papers etc. However, these requirements which were to be fulfilled till 31st July 2022 to avail the benefit of promotion retrospectively has been further extended upto 31st July 2024 vide Public Notice No. 27/P&AP/Pay/01/2021-22/75 (Mar.) dated 06.09.2022 published by AICTE. It is thus clear that the above mentioned additional qualifications are included in the mandatory requirements which they can now fulfill till 31st July 2024 so that faculty members can avail the benefit of promotion retrospectively as outlined under para 1.4 (C) of AICTE Gazette Notification dated 1st March 2019.
