	Estate officer informed that the Institute was established by Ministry of Education (MOE), Govt. of India in the year 1989 and formally inaugurated on 20.12.1991. Further, the Institute is centrally located between two main villages i. e. Duggan and Longowal. The entry gates at both ends are provided with MS gate (Duggan/Longowal) at both sides. The purpose of the proposal is reconstruction/re-designing/up-gradation of the façade and beautification of the entry gates/area at both the ends of the entrance gates with the provision of landscaping.  Hence, the design competition shall be held among the creative and innovative driven minds of the Institute to give presentation/architectural view along with design. plan, elevation, sketch, and concept relevant with theme for both the Entrance gates. Further, the constituted committee of officials shall evaluate and finalize the received proposals. The detailed structural drawings and preliminary/detailed estimate shall be prepared based on the final proposal accepted by the committee.
