Total number of available fellowships are 03 Full time PhD seats (including 2 for seat(s) for C2S Programme) and 01 Part Time PhD seat. Undergraduate students with valid Gate/NET score and Post Graduate students in relevant fields of Engineering/Technology who are interested in pursuing research in relevant areas may apply for admission to a full time Ph.D. program with fellowship Visvesvaraya PhD scheme for Electronics and IT: Phase-II for 2025-26 (odd semester).

The major features of the scheme for the full-time scholars are given below:

Fellowship: Rs. 38,750/- per month in 1st and 2nd year and @Rs. 43,750 per month in 3rd, 4th and 5th years of Ph.D. (support till PhD completion or 5 years whichever is earlier).

Research contingency Grant Support: An amount of Rs. 1,20,000/Year/Full-time PhD candidate for support duration of PhD candidate.

(A) Eligibility Criteria:

For the candidates who have qualified **GATE/NET during the last 5 years (Year- 2021 onwards)** in relevant branch of Engineering/Technology.

NOTE:

- (i) Relaxation in qualifying marks for reserved categories (SC/ST/OBC-Non-Creamy layer/Differently abled, etc.) shall be given as per Government of India guidelines.
- (ii) Relevant branch/Discipline shall be as per AICTE/UGC guidelines issued from time to time, as applicable. Details shall be provided on the institute website as per the guidelines of these regulatory authorities.
- (iii) The candidates should have qualified GATE/NET during the last 5 years (Year- 2021 onwards)
- (iv) The GATE/NET qualified candidates shall only be eligible for admissions in Full Time Ph.D. programme under Visvesvaraya PhD scheme.
- (v) Eligibility is subject to minimum of 60 % marks in UG or equivalent grade in Bachelor's and 55% marks in Master's degree.

Distribution of seats under Visvesvaraya PhD scheme is as under for 2025-26:

- a) 03 Full time PhD seats (including 2 for seat (s) for C2S Programme).
- b) 01 Part Time PhD seat.

Field of specialization to be considered for admission:

Electronics, Communications, Computer Science, Instrumentation, Biomedical, Mechanical, Microelectronics/ Solid-state Technology, MEMS, Nanoscience, Nano-Technology, Material Science, Engineering Physics or equivalent.
