Raj Singh Guru, Assistant vide his consent dt. 20.03.2025 has informed that a representation regarding deficiency in Promotion Reservation Roter for the post of Superintendent has already been submitted in the office of the Registrar, which is under consideration at appropriate levels.

01 consent of Sh. Jarnail Singh, LDC is received, who is not eligible to be considered for promotion to the post of UDC, being having less than five years' experience on the post of LDC, as on today, in view of approval of Competent Authority dt. 09.03.2025 regarding minimum 05 (five) years' experience for consideration of LDCs for promotion to the post of UDC & JSS.

Another employee Sh. Ramshabad Ram, Technician (Workshop) has also submitted his consent, but he had not submitted his Property return within permissible time, hence the CVO has denied his vigilance clearance certificate, with a comment that it is upto C.A. to decide the matter.

It was also quoted in the said Notification that the employees, who don't submit the consent form in time/late submission of consent forms, will not be considered by DPC for promotion, and no correspondence will be entertained in this regard. Through this Notification, all the eligible employees, whosoever have submitted their consent in time and their names are not mentioned in the above table are requested to contact the undersigned by 11:00 a.m. on 24.03.2025 (Monday), otherwise the office will not be responsible for missing of their names and the process of DPC will be started accordingly.

Further as per approval of Competent Authority, SLIET written test for the post of Assistant (Group-B) will be held on 24.03.2025 (Monday) at 3:00 P.M. in the Meeting Room, 1<sup>st</sup> Floor, Administration Section (Room No. 207), Administrative Block of the Institute. Due to receipt of no consent for the posts of Data Entry Operator & Jr. Scale Stenographer, no skill test will take place. The candidates, who have submitted their consents for the post of Lower Division Clerk are exempted from passing Typewriting test for being above 45 years of age on the date of consideration by DPC as per DoPT OM No. 14020/2/91\_estt. (D) dated 29.09.1992 and 14020/1/20/2014/Estt (D) dated 22.04.2015 as approved by the BoM in its 34th meeting held on 30.12.2019.
