**NOTICE**

The Institute vide issued Notice No. SLIET/Admn./REC/2025-26/954 dated 11.06.2025, uploaded the Preliminary Screening Committee report of Department of Computer Science & Engineering for information of candidates. The candidates were asked to submit grievances/representations, if any, with relevant documents in support of their claims within 07 days from the date of this notice i.e., upto 18.06.2025.

The representations, received from the candidates upto 18.06.2025, with regard to marks given by Preliminary Screening Committees were re-checked by the concerned committee and revised marks given to such candidates are uploaded on Institute Website for information of the candidates.

It is again clarified that the documents, which were not submitted with hard-copy of the application and pertaining to period after the last date of submission of the applications i.e., 31.08.2023 are not considered/taken into account as already conveyed at point-7 of Notice No. SLIET/Admn./REC/2024-25/25 dated 1 April 2025.

Some of the candidates submitted representations regarding INVALIDITY of their OBC-NCL and EWS certificates. It is for information for all such candidates that the crucial date of eligibility for these recruitment was 31.08.2023 i.e., the last date of receipt of online applications.

As per GoI instructions issued from time to time, the date of issuance of OBC-NCL and EWS certificates should had been issued between 01.04.2023 and 31.08.2023 and format should be as per prescribed by GoI for applying posts under Govt. of India. The following clauses were given in the Recruitment Notice that:

- As per Clause 19 of Recruitment Notice, **the statutory provision for relaxation prescribed by Govt. of India in case of the candidates belonging to reserved categories will be made applicable to them.**
- As per Clause 21 of Recruitment Notice, **the SC/ST/OBC-NCL/PwBD/EWS certificates should have been issued by the competent authority designated by Central / respective State/ UT Government and should be valid as on the closing date for submission of application.** Divyang / PwBD certificate should mention percentage of disability.

The OBC-NCL and EWS Certificates issued before 01.04.2023 and after 31.08.2023 are INVALID and cannot be considered for providing reservations against this Recruitment Notice issued by SLIET, Longowal.

Accordingly, all such representations stand disposed of and no communication in this regard shall be entertained by the Institute.
