Subject: Scholarship of Rs. 1.5 Lakh annually for UG students sponsored by Three of our Alumnus.

We are pleased to inform all concerned that during **Confluence 2025** held on 8-9 February at SLIET, Longowal, our esteemed Alumnus **Mr.Gaurav Chhatwal, Mr. Sarabjit Singh Puri, and Mr. Saurav Aggarwal**, generously offered to sponsor an annual scholarship of Rs. 1.5 Lakh (Rs. 50,000/- each) named as GSS-SCHOLARS to our deserving and financially deprived students of under graduate level. Accordingly on behalf of SLIET & SAA family we are thankful and appreciate their efforts and concerns towards their Alma-matter. Applications are invited from Final Year students for the academic session 2025-26 for GSS-SCHOLARS by using prescribed format. Last date for submission by 31st August 2025.

1.Key Highlights: Eligibility Criteria

- GSS-SCHOLARS stipend will be valid for only FINAL year undergraduates(the amount will be offered before the start of the last year of their degree course, irrespective of branch).
- An amount of Rs. 25,000/-(INR twenty-five thousand only) will be distributed among 6(six) financially weaker section students who have shown continued academic excellence by securing an overall CGPA of 7.00(minimum) before the start of their final year.
- The candidate should have a clear record with no disciplinary action taken and no supplementary exam or backlog of exams in his/her entire UG course.
- Scholarships will be offered to 06 students on above criteria after scrutiny of papers(academic and financial) and interview with the candidates.
- Candidates must approach Dean(A&IR) 2 months before the start of the last year or as scholarship dates announced by Dean(A&IR) office. For the session 2025-26 applications are invited till 30.8.2025.
- Shortlisted candidates will be notified by the Dean(A&IR).. and the FINAL list of students will be also displayed on the website(every year) after the result of the pre-final year only.
- Final list of the 6 (six) worthy and selected students for scholarship will be published only after a digitally signed or an approval by all 03 sponsors.
- After receiving applications from students(till notified date by Dean(A&IR) office. Constituted committee will evaluate and decide the candidature on the basis of their merit (on the basis of their CGPA and family income certificate).

2. Evaluation Committee:

After receiving applications the following committee will evaluate and decide the candidature on basis of the above Eligibility Criteria.
