**Subject: Admission to Full Time Ph.D. Programme under Visvesvaraya Ph.D. scheme under C2S programme for Electronics and IT: Phase-II (odd Semester 2025, Academic Year 2025-26) as Full Time Scholar with Fellowship.**

**Implementation Order No. PhD-04/04-2025/72 dated: 02/04/2025.**

Consequent upon the recommendations of Selection Committee dated: 29/09/2025 and the approval of Competent Authority, you are hereby admitted to **Ph.D. programme as Full Time Scholar with Fellowship under Visvesvaraya Ph.D. scheme under C2S programme for Electronics and IT: II** in the Department of Mathematics, subject to approval of the SENATE on following terms and conditions:

1. You will be governed by the "Ordinances, Rules and Regulations for Doctor of Philosophy (Ph.D.) Degree, 2018" of the Institute, as amended from time to time, Guidelines issued by Ministry of Education (MOE), Government of India, and Regulation of University Grants Commission for Ph.D. Scholars from time to time. And as per Implementation Order No. PhD-04/04-2025/72 dated: 02/04/2025 of Digital India Corporation, Ministry of Electronics and Information Technology, GOI, New Delhi. You are required to work as per C2S scheme and give undertaking that you are agreed to follow terms and conditions and standard operating procedure of above said Visvesvaraya Ph.D. scheme and this admission letter.
2. You will be paid fellowship @ Rs. 38, 750/- per month in 1<sup>st</sup> and 2<sup>nd</sup> years from the date of joining in the Department, initially for a period of 02 years. The fellowship is extendable, based upon satisfactory performance evaluation report, subject to decision of the SENATE and ratification by the Board of Management. As per the scheme, the fellowship in the extended period will be @ Rs. 43, 750/- per month in 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> years of Ph.D. (support till Ph.D. completion or 60 months whichever is earlier).
3. In case, it is found at any stage during the course of study that the information furnished by you is incorrect or misleading or ineligibility is detected, your candidature will be cancelled.
4. Your progress of work and performance will be monitored after every six months by RPC/DRC and the fellowship may be withdrawn at any time if the progress and performance are not found satisfactory. Any three unsatisfactory reports (half yearly) shall be treated as cancellation of Ph.D. registration. First unsatisfactory report of supervisor (s) / RPC / DRC will put the candidate on scholastic probation- I, second unsatisfactory report will put the Research Scholar on scholastic probation-II and so on.
5. The overpayment of fellowship, if any, shall be deducted/recoverable as per rules of the Institute.
6. In case, you are found ineligible w.r.t. admissibility of fellowship at any stage during the course of study, the fellowship will be stopped and the already paid fellowship will be recovered.
7. If your studentship is terminated due to non-performance or you leave in between the Ph.D. programme, you have to refund the fellowship and contingency in full or in part as per clause 2.6 of Ordinances, Rules and Regulations for Doctor of Philosophy (Ph.D.) Degree, 2018 to the MoE through Nodal Officer, SLIET, Longowal.
8. In case you do not register yourself by the due dates in each semester, your registration shall be reviewed by the DRC and CRC. Further, if you fail to register on time second time, or does not register for two consecutive semesters during the course of study, your registration shall withstand cancelled.
